



INTRODUCTION

Relevance and justification of master's research topic. The main purpose of all reformation is to develop stable economy of Republic of Uzbekistan by altering content of the economy. One of the crucial points of this are reforms and model role of other countries, particularly China which is the focus of this dissertation. Which is also can be used to prevent and avoid future probable problems.
