



## Introduction

**Relevance and justification of master's research topic.** The main purpose of all reformation is to develop stable economy of Republic of Uzbekistan by altering content of the economy. This activity is directly dedicated to advance process of investment in main basic branches of national economy as one of the ways which helps modernize real sector companies.

President of Uzbekistan Shavkat Mirziyoyev signed a decree "On Uzbekistan's Development Strategy"<sup>1</sup> in 7 of February in 2017. The document has approved Uzbekistan's Five – Area Development Strategy for 2017 – 2021 in which high paths our country has to achieve is outlined, as well as mechanism of increasing people's living circumstance.

The main purpose of organizational and legal measurements of Development Strategy is to increase well – being of nation and to develop potential of country and society as appropriate for globalization process of the world. In addition, demands of global market conjuncture have to be taken into consideration while developing potential of the country.

Realization of third area measurements of Development strategy, namely economic development and liberalization, demand followings: provision of constancy of national currency and costs, step by step utilization of modern market mechanisms to make order currency, enlargement of income basis of local budgets, increase foreign economic relationship, put into practice modern technologies in order to produce products and materials for export, development of transport – logistics of the country, development of entrepreneurial business and increase attractiveness of investments for foreign investors, improvement of tax administration, implementation of up-to-date mechanisms and principles of making order bank activities.

During 2017 – 2021 realizing branch program that means 649 investment projects, total cost amounts to 40 billion dollar, is planning. As a result, five years
